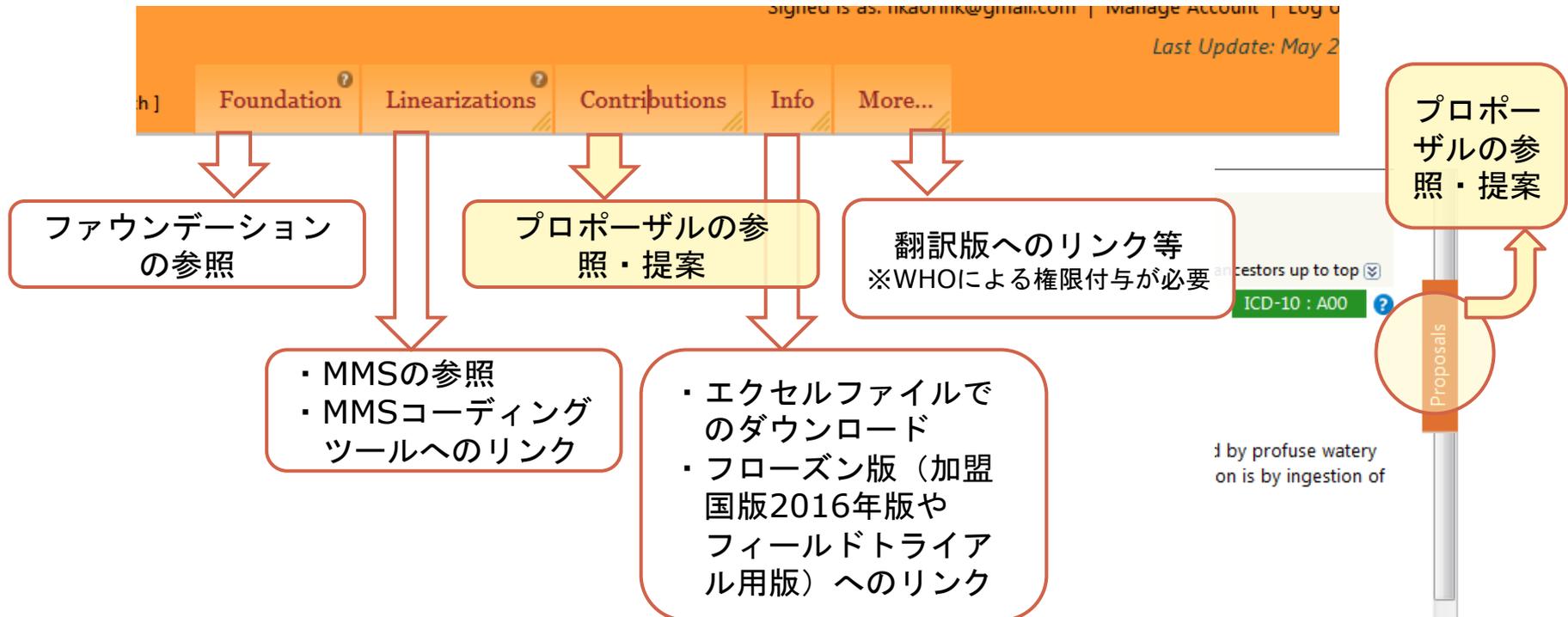

Make proposals:

- 1. Content Enhancement**
 - Change or improve existing content, including title, definition, add an additional term, multiple parent, etc.
- 2. New Entity**
 - Create a new concept that does not already exist within the classification
 - Requires not just the title of the new entity, but the full content model as outlined on the form (e.g. definition, terms, etc.)
 - Multiple new entities require multiple proposals.
- 3. Delete an Entity**
 - Remove a concept that does exist within the classification, either because it is obsolete, a duplicate, or otherwise should not be included
- 4. Complex Hierarchical Proposal**
 - Change which is the linearization parent, change an ordering, move something within the hierarchy, change the structure, propose to "split" or "merge" concepts, etc.

※ Additional proposal types may be available, as needed, in the future

- Agree or Disagree
- When disagree, it is required to submit a new proposal, rather than adding comments to the other proposal.
